2019 RULES & REGULATIONS (Keep this rules page for your records!)

1. All commercial applicants must submit a minimum of 3 images of artwork by emailing them to FentonArtWalk@slpr.net. If you are unable to send digital images of your work, please mail your submissions to SLPR 150 S. Leroy St., Fenton, MI 48430. Photos will not be returned.
2. The Fenton ArtWalk Festival will be held on **Saturday, July 13 (10 am to 7 pm)**. Event takes place regardless of weather.
3. All work exhibited must be original and handcrafted by the artist. The limited use of manufactured items is allowed only if they are small components of the final product.
4. Artist must be present for the entire ARTWALK event.
5. Your non-refundable commercial application fee (\$10.00) and booth fee (\$40.00 per 10'x10' booth space) are to be paid by one check. MAKE ALL CHECKS PAYABLE TO "SLPR." If you are not selected for the event, your \$40 booth fee(s) will be refunded.
6. Local non-profits groups will be charged a non-refundable fee of \$20 dollars for each 10'x10' space in the show (additional booths are \$20/booth). Locations for local non-profits are subject to change depending on number of commercial vendors.
7. Fenton DDA member may sponsor an artist for a booth fee of \$40.00 (the \$10 application fee will be waived as a courtesy to Fenton DDA members).
8. ALL COMMERCIAL APPLICATIONS WILL BE JURIED and will receive notification of show status by **April 13th, 2018**. Applicants will be notified of show status via email. Applications received after April 13th 2018 will be reviewed as time permits.
9. No refunds will be given after the date of **April 13, 2018**. Cancellations after this date are nonrefundable. No refunds will be given due to the cancellation of the event by an act of God, local authorities, or a weather-related incident.
10. Absolutely all inventory, boxes, artwork, etc. must be contained within your booth space and cannot interfere with adjacent exhibits or walkways in any way.
11. Artists are responsible for their own property and for furnishing their own tents, tables, chairs and change. Artists are responsible for insurance and protection of artwork and display. SLPR, The Fenton DDA, and City of Fenton are not responsible for damage to artwork or display.
12. Artists requiring electricity are responsible for supplying their own extension cords. The cords must be damage free, heavy duty, three-prong grounded, outdoor rated, able to carry at 15 amps and be a minimum of 100 feet long. Electricity access is limited during the event.
13. Exhibitors agree to conduct themselves in a respectful manner. Any behavior deemed inappropriate by SLPR may result in expulsion. ArtWalk is intended to be a family friendly event, free of radical and disturbing displays/outbursts.
14. Exhibitors are not allowed to bring or display weaponry for the duration of the event.
15. Violation of any rules is a basis for expulsion.
