1. If you are unable to attend, please call or send me a text on 248-245-0045.

- 2. There needs to be 2 vendors in each booth, 1 to handle the money and 1 to handle the product.
- 3. Vendors and employees must wear gloves and **masks**. (If you handle money, you need to change your gloves before you handle product or use hand santizer)
- 4. You need to have a table in front of you with a list of your products and the prices and behind you should be your product so you are the only one touching it.
- 5. Plastic tablecloths are recommended for your table.
- 6. We need to remember to use social distancing with the customers.
- 7. Food Trucks and Beverages must follow restaurant guidelines at this time.
- 8. Food is to be treated as carry-out, there will be no food consumption at the market.
- 9. Wine and ground coffee can be sold but no samples can be hand out.
- 10. Food samples must be made in advance in enclosed containers, make sure you space it out when handling them out.
- 11. We will have 2 handwashing stations and a port-a-potty at the Market.
- 12. PLEASE TURN IN ALL TOKENS AT THE END OF THE MARKET EACH WEEK SO THEY CAN BE DISINFECTED. (Also, there is no limit at this time which may cause us to run out of tokens if they are not turned in.)

Cannabis Products:

Applications from vendors selling cannabis products will only be considered if products are limited to hulled hemp seed, hemp seed protein powder, hemp seed oil, topical CBD and smokable hemp flower. Vendor selling marijuana products, CBD edibles, CBD pet treats and viable hemp seeds, starts and plants will not be considered. CBD products must be clearly labeled and marketed for topical use only. Vendors selling topical CBD products and smokable hemp flower must possess a valid Processor-Handler License for cannabis products.

- Wholesale Items
- Commercially Produced Items
- Reselling

What can be sold at the Market? The following products are permitted for sale.

Farm Checks

Farm checks *may* be performed at the discretion of the Market Board; this is to ensure and protect the integrity of the Fenton Markets. Failing to provide accurate information pertaining to the location of goods grown could result in termination from the market with no refund of fees.

Licensing & Certifications

Vendors are responsible for their own sales taxes, licensing fees, and permits for operation and will abide by local, state and federal laws. Food item and produce vendors (if applicable) and meat vendors must provide a copy of all current licensing from the Michigan Dept. of Agriculture and/or Genesee County Health Dept. along with any pertinent liability insurance with their application or follow the Cottage Food Bill rules and regulations.

Cancellations

If vendor is unable to be in attendance please notify by text or call Pat Allen @248-245-0045 or the SLP&R office, 810-714-Please check the Fenton Market Facebook pages for any updates or changes. The Market will be held rain or shine. It is left up to vendors' discretion to attend or not in case of rain. The Markets will be cancelled if tornado warnings are issued.

Not Allowed/Please refrain from the following

- Being late to set up
- Driving vehicles on the grass or resident's property
- No stakes in the pavement
- Overlapping on other spaces or blocking nearby spaces with vehicles, tables, etc.
- Placing food on the ground
- No early departures
- No smoking
- Alcoholic beverages are not permitted in the market Unless vendor is a licensed wine merchant.
- Use of abusive or foul language will not be tolerated towards anyone
- Vendors are not allowed to bring pets
- Vendors are not allowed to have any type of weapons on them during the market.
- No resale or pre-manufactured goods
- No hawking

Vendor Requirements

- Vehicles must be out of the market ASAP after unloading. •
- Tents must be anchored with weights.
- Responsible for cleaning their space before leaving the market.
- All trash needs to be hauled to the dumpster located in the parking lot.
- Submit their weekly sales.
- Food items must be labeled with all ingredients and allergens.
- All questions regarding other vendors go to the Market Manager.

Terminations

- Failing to submit and/or display license and permits
- Violation of Market rules & guidelines, state and local laws and guidelines
- Failure to attend the Market on three or more days (unexcused no-call, no show days)
- False production of goods

Provide all equipment (tents, tables, chairs, etc...)

<u>Tokens</u>

- Tokens are available to customers using credit card or EBT cards.
- EBT cards may only be used to purchase food. Hot food is not allowed.
- Signs will be provided to vendors that participate with the tokens and Double Up Food Bucks.
- ALL TOKENS ARE TO BE TURNED IN BY THE LAST DAY OF THE MARKET FOR THE CURRENT SEASON

Suspension or Removal of a vendor from the Market

- Failure to follow state, local government or Market rules & regulations
- Unsanitary or unsafe conditions at the Market
- Unreasonable conduct considered detrimental to the Market

Prepared Food Farmed Products Artisan Information

Vendors must list all products they wish to sell at the Fenton Farmers Market. Additional products may be added contingent upon Market Manager's approval at any point during the season. All items for sale must follow state health codes and regulations.

- Prepared foods include items such as baked goods, hot foods, coffee, pasta, and cheese.
- Value-added products are items such as jams and jellies sold by a vendor-grower or local artisan who has grown/assembled the main ingredients.
- Artisan items must be created/designed/assembled by vendor. No buy/sell items. Please include pictures of your items. Additional paper may be used if more room is needed.
