### Call to Order

Chairperson Lockwood called the meeting to order at 6:00pm

## 2021 Audit Presentation: Kevin Kelley, CPA Manager – Lewis/Knopf

Kevin Kelley presented the 2021 audit via zoom and prepared a report summary for the board. SLPR received a "Clean" "Unmodified" audit opinion. This is the highest level of assurance possible for the District's financial statements. A discussion followed re: investment options to which Mr. Kelley explained there may be limitations on what a government can invest in and referred to Michigan Act 121, Local Government Investment Pool Act.

**Executive Director's Report:** Koledo gave an update of the pathway grant initiatives stating that the City of Fenton applied for and will receive funding for Veteran's Park next Summer. Also noted was the City of Linden was waiting to approve the final design for the Triangle Park Plan.

Koledo discussed community interactions, specifically the Fenton Area Public Schools' art show plans and their need for additional hooks. He described the shared partnership between FAPS, FCCC and the

City of Fenton Arts and Cultural committee to split the \$2,800 cost for the extra hooks and hanging cables. Also noted were the staff training with Fenton Fire Chief on the alarm and fire suppression system at FCCC and the upcoming Senior Luncheon events made possible with Fenton and Fenton Townships CDBG funding.

Koledo noted the storage warehouse and his efforts to find affordable shelving. Also noted was the potential disposal of the bounce house and the gymnastics program's use of Linden Schools' sports center. A discussion followed re: working together with the Linden School superintendent on a mutual message on SLPR's use of the sports center for its gymnastics program. Also discussed was an information campaign to manage the narrative on SLPR's future facility plan.

**Accounting Coordinator's Report:** Priestap discussed the recreation profit/loss statement noting overall programming is doing very well and that program profits support budgeted expenses of \$120,000 for 2022. She also noted the use of the dance fund to help offset the cost of the recital. A discussion followed re: the drop in the participation in the dance program potentially because of less program offerings or change in location.

Programmer's Report: A written report was submitted

## **Discussion Item: Easement Updates**

Koledo stated the remaining easements have ongoing negotiations. A discussion followed re: the cost to acquire them as was the total cost estimated by NFE to acquire all easements. It was noted that to get Michigan Trails funding, all easements have to be obtained before December. Further discussion was tabled until June.

### Discussion Item: Proposed Meeting Date Changes for June and July

Lockwood proposed changing the June regular monthly board meeting from June 23<sup>rd</sup> to June 16<sup>th</sup> at 8:00am and changing the July meeting from July 28<sup>th</sup> to July 21<sup>st</sup> at 8:00am. It was the consensus of the members present that the change is acceptable.

### **Action Item: Michigan Trails Fund Project Agreement**

Koledo presented the agreement that will award \$100,000 toward the completion of the non-motorized trails project stating both SLPR's attorney and NFE are comfortable with it and the deadline is June 1<sup>st</sup>.

Motion by Lockwood, seconded by Simons to approve the Michigan Trails Fund Project Agreement as presented.

### **Action Item: Charter Amendment Ballot Language**

Koledo presented the ballot language that will amend the Charter to change Article 5, the management and control of property. He read the ballot language as follows:

'Shall the Charter be amended to state that all lands purchased or developed with MDNR Grants be maintained as public land according to the MDNR Project Agreement and that, if the District is dissolved, lands acquired through MDNR grants will become the responsibility of the municipality in which it is located, which will assume all title and control?'

A discussion followed re: pre-approval of the ballot language is pending AG's approval.

Motion by Culbert, seconded by Lockwood to approve the ballot language as presented, subject to minor changes by the state AG's office.

Motion Carried: 4 Ayes, 0 Nays
