2023 RULES & REGULATIONS (Keep this rules page for your records!)

1. All applicants must submit a minimum of 3 images of artwork and 1 image of your booth by emailing them to contact_us@slpr.net. **DO NOT HAVE NAME OR LOGO VISIBLE IN ANY IMAGE.** If you are unable to send digital images of your work, please mail your submissions to **SLPR ATTN: Art Walk 150 S. Leroy St., Fenton, MI 48430. Photos will not be returned.**
2. All work exhibited must be original and handcrafted by the artist. The limited use of manufactured items is allowed only if they are small components of the final product.
3. Artist must be present for the entire Art Walk event.
4. **ALL APPLICATIONS WILL BE JURIED.** Artists selected will be notified by May 8th and will receive additional information at that time. Late registrations will be notified by June 9th. ***The \$20 Jury Fee is non-refundable, non-selects will have their application fees returned within 30 days of notification.***
5. **NO BOOTH REFUNDS WILL BE GIVEN. However, they can be transferred to 2024 with notification by July 7th, 2023. Cancellations received after this date are nontransferable.** No refunds will be given due to the cancellation of the event by an act of God, local authorities, or a weather-related incident.
6. Booth spaces are 10'x10'. Absolutely all inventory, boxes, artwork, etc. must be contained within your booth space and cannot interfere with adjacent exhibits or walkways in any way.
7. Artists are responsible for all sales tax on items they sell, for their own property, and for furnishing their own tents, tent weights, tables, chairs, and change. ***Tents must be weighted for safety, 10 lbs. minimum/post*** (20lbs./post is recommended). Artists are also responsible for insurance and protection of artwork and display. SLPR, the Fenton DDA, and the City of Fenton are not responsible for damage to artwork or display.
8. Be prepared to have all your ***items unloaded and your vehicle moved to the Vendor Parking Area ASAP Saturday morning starting at 6 AM.*** Specific directions for set up will be emailed to you on July 14th. At this time, there are no plans for a Friday night set up. But, if allowed, ***be aware that the area is open to pedestrians and security will not be provided overnight*** (however, police will be on patrol). ***SLPR, the Fenton DDA, or the City of Fenton will not be responsible for loss or damage to Art Walk participants property in any way or at any time.***
9. Artists requiring electricity are responsible for supplying their own extension cords and will be charged a ***\$25 fee for electrical access.*** The cords must be damage free, heavy duty, three-prong grounded, outdoor rated, able to carry 15 amps and be a minimum of 100 feet long. Electrical access is limited during the event and ***is not guaranteed and can only be requested during regular registration (prior to April 30th, 2023).*** Generators are ***NOT*** allowed.
10. Exhibitors agree to conduct themselves in a respectful manner. Any behavior deemed inappropriate by SLPR may result in expulsion. Art Walk is intended to be a family friendly event, free of radical and disturbing displays/outbursts.
11. In participating in the Fenton Art Walk you are giving permission for use of photos of you and your artwork for marketing purposes via print or social media.
12. Exhibitors are not allowed to bring or display weaponry for the duration of the event.
13. Violation of any rules is a basis for expulsion.
